Research Posting and Circulation to OSOT Membership

The Ontario Society of Occupational Therapists is committed to support occupational therapy research and will promote OSOT member participation in promoting research that support the development of knowledge about occupational therapy practice and/or occupational therapists.

To promote membership awareness of opportunities to participate in research activities relating to occupational therapy, the Society circulates a bi-monthly *Supporting Occupational Therapy Research* communique by email to all OSOT members (approximately 4, 400 Ontario occupational therapists and student occupational therapists) which will include researchers' project descriptions and any links to online surveys. In addition, the Society will post this information to the OSOT website. While the Society's encouragement will invite member participation, OSOT's commitment to the posting and circulation of research postings does not imply OSOT endorsement of the research methodology, findings, conclusions or recommendations.

Researchers interested in accessing participation of OSOT members are invited to include:

- A one-time email promotion of your project, including a brief project description and link to your online survey, if applicable. Select the *Supporting Occupational Therapy Research* communique that best suits your projects timelines – see schedule below.
- Posting of your project including a brief project description and link to your online survey, if applicable, on the [Research Postings](#) page of the OSOT website. This posting will stay up until your specified deadline for research participation.

Requirements

- Research must pertain to the practice of occupational therapy or issues of significant concern to Ontario occupational therapists
- In order for research circulation requests to be considered, OSOT must be sent the following in a word document:
 - Study title
 - Ethics approval and REB number
 - Target audience for participation
 - Deadline for research participation
 - Principal & Co-Investigators (with titles)
 - Purpose & brief description of study
 - Link to electronic survey, if applicable
 - Desired date for email circulation

- Applications and fees should be submitted to the OSOT office a minimum of 3 days in advance of the next scheduled Support Occupational Therapy Research communique in order to be considered. Applications that do not make that deadline will be pushed to the next email blast.
- Advertisements to be posted are subject to OSOT research policies. OSOT reserves the right to refuse any request of research posting circulation.

Proofing and Approval

Researchers will have opportunity to review and approve the posting of their project information, providing application and content is received at least 3 days in advance of the *Supporting Occupational Therapy Research* communique circulation date.
