OSOT is your professional organization and with members' input has developed a dynamic strategic vision and plan. Over 4,600 Ontario Occupational Therapists and Student OTs are committed to **proactively support, promote and position the profession of occupational therapy in Ontario**.

The Society is governed by an 8-member volunteer Board of Directors who provide stewardship and direction to the activities and resources of the association. (9 members in years when a President-Elect is in office)

The Board meets approximately 6-8 times per year, typically for a full day weekend meeting in Toronto. Attendance is expected. Increasingly tele/video conferencing and email communications provide options for Board functioning. Volunteers are supported to assume their Board roles with expenses related to travel and administration reimbursed.

OSOT is a welcoming community that seeks to live its commitment to values of diversity and inclusion. A diverse composition of our board is valued and we encourage persons from diverse geographies, and traditionally underserved communities to put their name forward.

Directors of the Corporation shall:

- 1. be an Active or Honourary Life, voting member of the Society
- 2. be not less than 21 years of age
- 3. have a minimum of three (3) years of OT practice experience*
- 4. have a minimum of one (1) year of service as an OSOT Team Member **

* Criteria 3 may be waived by the Board of Directors upon request of the candidate

** Criteria 4 may be waived if the nominee has related volunteer committee/governance experience upon request
