How will a virtual conference work?

Before the Conference

1. Register on the OSOT website. If you are interested in a workshop but are unable to attend live, you can still register as a recording of the presentation will be sent to all registrants and will be available until January 5, 2022.

Power Wheelchair Controls: Thinking Beyond the Standard Joystick

Kathy Fisher, BSc (OT)

Power wheelchair technology has developed to allow a personalized driving experience to maximize a client's ongoing functional potential. For many clients a basic joystick is not sufficient to meet their needs in all environments due to limitations in strength, coordination and fatigue. Many alternative driver controls exist but how do you as a clinician make the best recommendation? This session will highlight these innovations and will present the options based on assessment considerations. These include:

- determination of short vs. long term function
- what determines basic and essential need?
- timing when do you introduce non-standard joystick options?
- proportional vs non proportional driving what are the options and which gives you client more accurate control and safety?
- access to technology is your client (and caregivers) able to manage the technology and can it be set up to minimize steps to access functions?

Tiered Approaches to Occupational Therapy Services in Schools: What Works for Whom, When, Why, and How?

Sandra VanderKaay, PhD, OT Reg. (Ont.) and Wenonah Campbell, PhD

In this interactive and evidence-based session, the speakers will extend knowledge and understanding of tiered schoolbased occupational therapy practice to support children's participation and inclusion. Speakers describe their recent research, including a review of relevant literature and a retrospective evaluation of our tiered model for school-based occupational therapy, Partnering for Change (P4C). They will share findings regarding contexts and mechanisms that support successful outcomes in tiered approaches, and describe how they expect findings can be used to guide schoolbased occupational therapy practice.

Ontario Health Teams: How Occupational Therapy Can Support an Integrated Health System

Panel of occupational therapists and decision makers moderated by Catherine Donnelly, PhD, OT Reg. (Ont.)

This session will introduce participants to Ontario Health Teams (OHTs), including the vision of OHTs in supporting an integrated and community connected health system. Foundational concepts of OHTs including the concept of a Learning Health System, Patient Medical/Health Homes and Patient Medical/Health Neighbourhoods will be explored. Panelists, including decision makers and occupational therapists, will share examples of how occupational therapy has supported integrated healthcare in their OHT.

Let's Chat – Avoid These Common Auto Insurance Practice Pitfalls!

This session will review examples of common questions from occupational therapists and pitfalls working within the auto sector. Speakers will explore "how to" questions related to:

Occupational Therapists in Emergency Medical Services

This session will describe the current practice of Emergency Medical Services (EMS) across Ontario for 911 calls and define the role of occupational therapy within Niagara Emergency Medical Services; specifically, on the Falls Intervention Team (FIT). Participants will gain a basic understanding of the Mobile Integrated Health teams and learn of current shifts in health system service delivery models. Speakers will share why this work is important and discuss the future of allied partners within EMS.

Reframing Listening: Exploring the Subjective Experience of Autistic Youth During Their Transition Into Adulthood

Youth on the Autism Spectrum

The focus of this session is to create space for the voices of Autistic youth to share their perspectives and experiences around their occupational transition into adulthood. The nature of reframing listening will be addressed through the purposeful construction of the workshop and in a way that centres neurodiversity and is shared through multimodal means. Future priority areas will be discussed to better support youth on the Autism spectrum during this important time of their life.

Material Matters: The Substance and Design of Seating Components

Brenlee Mogul-Rotman, OT Reg (Ont.)

This session will outline the advantages and limitations of seating solutions based upon scientific principles, design factors and how the materials choices are applied clinically to address the clients' needs. Specific attention will focus on how client movement throughout the day, changes in posture over time, and clinical and best practice guidelines can impact the seating and positioning component decision-making process. By the end of the presentation, participants will be able to state at least 2 types of forces applied to a body depending on the type of material and design of a cushion and recognize clinical significance of applied forces to the body related to the design and materials used in construction of seating components. They will also articulate 3 types of changes in client condition/function and how to optimize outcomes through seating materials and design selection and predict 3 aspects of how to apply clinical/best practice guidelines to achieve optimal pressure management and positioning outcomes with seating components.

What's the New Ontario Autism Program (OAP) All About?

Debra Kennedy, OT Reg (Ont.)

Participants in this session will become aware of the new service streams in the OAP and how occupational therapists can participate and support Autistic children and their families. The session will provide an update on the status of new program streams - Family Foundational Services, Care-giver Mediated Early Years Programs, Entry to School, Urgent Services and Core Clinical Services. It will also focus on Core Clinical Services and the Determination of Needs Process that identifies funding allocations for families of children and youth with Autism and provide an opportunity for OTs to network and share their knowledge and experiences with each of the program streams.

Financial Considerations for OTs in the Private (Auto) Sector

Hazel Wood, OT Reg (Ont.), Sarah Macrae, OT Reg (Ont.) and Maria Stella Puopolo, OT Reg (Ont.)

OTs working in the Private (Auto) Sector face unique financial challenges. The Financial Services Commission of Ontario (FSCO) has not updated the Professional Services Guideline since 2014; and that Guideline only provided minimal fee increases. Furthermore, as IE companies compete for market share, they drive fees down even more. Operating costs have also increased with inflation (e.g., petroleum, office expenses, cell, etc.). This session aims to empower OTs to recognize their true worth, how to negotiate fees, and explore the future cost of care.

How Do People Actually Use Their Manual Wheelchairs, and What Really Matters?

This session will examine the real-world behaviours of manual wheelchair users and discuss the mechanical principles and factors that affect propulsion efficiency. By the end of the presentation, participants will be able to cite 2 examples of how end users move about in wheelchairs during everyday life and describe 3 component selections that impact propulsion efficiency of a manual wheelchair. Participants will be able to describe 3 physical principles that impact propulsion efficiency of a manual wheelchair and list 3 locations or components on a manual wheelchair where manufacturers have attempted to reduce the transmission of whole-body vibration to the user.

"Has There Been a Change?": Early Identification of Functional Decline in Older Adults

Dana Corsi, MScHQ, OT Reg. (Ont.)

It is common for older adults accessing healthcare across the continuum to experience functional changes as a result of an acute illness or accumulation of deficits over time. Participants will learn and apply a pragmatic approach to early identification of functional decline that can be used across the continuum of care. Participants will understand key considerations for implementing an approach to early identification of functional decline in older adults, with a focus on baseline functional status and restorative potential.

Virtual Supervision of OT Students: A Brave New World!

Anne Hunt, PhD, OT Reg. (Ont.), Shone Joos, OT Reg. (Ont.), and Eleanor Furtado, MScOT

This session will be of interest to clinicians who are considering taking on a student in a virtual practice setting and those who may have already engaged in virtual supervision. The session will cover current best practices in virtual supervision and describe strategies and share resources to support virtual supervision. A case study of a successful virtual student supervision experience will be discussed.

Supporting Individuals Who Experience Homelessness: A Call to Occupational Therapy This session has been cancelled.

As homelessness continues to grow in high-income countries internationally, an increasing number of occupational therapists are supporting individuals who experience homelessness in direct and indirect roles. This workshop will provide a summary of practices and research related to occupational therapy and homelessness across Canada and the Bridging the Transition Framework, a framework aimed at guiding the practice of occupational therapists across the trajectory of unhoused to housing. The session will build on this knowledge by engaging participants in discussions about how practice and research innovations in occupational therapy may fill gaps in existing supports in Ontario and beyond using an occupational lens.

Meaningful Connections in the Time of COVID: How OTs Can Use the Guide to Virtual Creative Engagement for Older Adults (VCE Guide) To Battle Geriatric Isolation

This session will introduce the participants to the newly created VCE Guide and how to best utilize this tool to promote and encourage the use of meaningful virtual programming and resources as a manner to improve quality of life and decrease the negative effects of isolation within homebound seniors. This session will highlight the devastating emotional, cognitive and physical effects of senior isolation and explore why OT professionals can be at the forefront of making positive change.

OT and Vision Loss: Enhancing Accessibility in Your Practice

This session will provide an overview of visual conditions and visual function and its impact on occupation across the lifespan, as well as general principles and accessibility strategies that generalist occupational therapists can apply to increase the accessibility of their services in support of clients with blindness and vision loss. Presenters will provide an overview of the diverse OT role in vision rehabilitation in Ontario and the range of collaboration needed for successful outcomes. Mental Health as the Next Pandemic Wave: Implications and Opportunities for Occupational Therapists
